#### **Laptop Program Operation and Distribution**

- Students will be provided with a laptop for 24/7 use through the MDS Laptop Provision Scheme.
- Parents and students may select the laptop that best suits their needs from the school generated list
- The cost of the laptop is spread over three years with negotiated payments required by March 31st each calendar year
- All laptops and batteries are covered by a three year manufacturer's warranty. The warranty covers manufacturer's defects and normal use of the laptop. It does not cover negligence, abuse, malicious or accidental damage. (e.g cracked LCD screens are not covered under warranty). Where damages occur or repairs are needed to out-of-warranty laptops, all costs will be at the student's expense
- A daily borrowing option will be available to students who do not wish to participate in the purchase option
- All laptops have the required software for classes loaded (to a value in excess of \$1000) and licences remain valid while the student is enrolled at MDS
- These devices will be fully supported by the school's IT staff
- Powering or charging of devices at school will not be possible due to WHS compliance advice

#### **Student's Responsibilities**

- Given that students will have responsibility for an expensive electronic device it is expected that when not in use it will be locked securely in their locker
- Laptops must be brought to school fully charged to last a full day of learning
- Students leaving the school before the full term of the laptop contract have the choice of either returning their financially up to date laptop to the school in good working order and receive a pro-rata refund or paying out the remaining contract fees and retaining the laptop

- STUDENTS WILL NEED TO SET UP THEIR DEVICE AS PER THE DEVICE OWNER'S MANUAL; this includes Battery conditioning, Operating System updates and virus protection updates
